Design, Construction & Finance for Balance Work of Housing Project at 185, Torrington Mawatha, Colombo.

1. The Chairman, Standing Cabinet Appointed Procurement Committee of Ministry of Megapolis and Western Development on behalf of the Urban Development Authority (UDA) invites sealed bids from eligible and qualified bidders for Design, Construction & Finance for balance work of housing project and remedying any defects therein land located at Torrington Mawatha, Colombo on Design & Build basis as described below.

Project Scope

Construction of 120 Housing units in Torrington Mawatha accommodated in (G + 11) 12 storied buildings consisting of 400 sqft carpet area housing units. Each housing unit includes two bed rooms, living area, kitchen, dining area and toilet.

➤ Main features

- Carpet area of a housing unit shall be 400 sqft.
- No. of floors shall be 12.
- Community hall - Minimum of 1200sqft area
- Shops - 05 no of shops
- Common toilet - Two lockable common toilets
- Police post cum fire commanding center - Minimum of 400 sqft carpet area
- Grama Niladari office - Minimum of 200sqft area
- Health center - Minimum of 400sqft area
- Maintenance office Minimum of 400 sqft carpet area
- Janitorial room: Minimum of 30 ft² area

➤ Housing Unit consist with

- Living room
- 02 Bed rooms in two different sizes
- Kitchen, dining area

- Toilet and Bath with a separation
- Balcony

2. Bidding will be conducted through **National Competitive Bidding Procedure.**

3 To be eligible for Contract award, the successful bidder shall not have been blacklisted and the eligible Bidders shall comply with,

- One of the following qualification criteria;

I. Local Developers / Contractors who registered with Construction Industry Development Authority (CIDA) and having level C2 or above

or

II. Foreign or local contractors or developers who have demonstrated required experience in developing and constructing similar housing projects in Sri Lanka or in abroad.

or

III. Bidders who do not fulfill one of the above requirements could be considered if they have demonstrated required financial capacity to carry out the proposed project. In these circumstances, developer / investor should be required to undertake the construction as a joint venture with a local contractor who registered with Construction Industry Development Authority (CIDA) and having level C2 or above.

and

- Average annual value of Turnover of construction work performed in the last 5 years shall be at least **LKR 225 Million.**

and

- Minimum of 50% Initial Contract Price shall be financed by the bidder and the total contract sum will be paid by the UDA after completion of the Project.

4 Contract Period – **18 months.**

- 7 Bids shall be delivered with duplicate to the following address **on or before 2.30p.m on 17th February 2017**. Late bids will be rejected. Bids will be opened soon after closing in the presence of the bidder's representative who chooses to attend.
