**RENOVATION OF 04 NOS. COMMON TOILET BLOCKS IN GROUND FLOOR  
OF SETHSIRIPAYA STAGE - I**

The Chairman, Procurement Committee of Urban Development Authority hereby invite Bids for Renovation of 04 Nos. Common Toilet Blocks in Ground Floor of Sethsiripaya Stage -I.

Bid Should be submitted on the forms obtainable between 9.00a.m. to 2.30 p.m. on any working day till 12<sup>th</sup> July, 2017 from the office of Engineering Services Division on submission of proofs for the ICTAD registration for building construction under category C8 or above and payment of non-refundable Tender fee of Rs. 500/= in cash.

The bid should be accompanied with a bid security to the value of Rs. 41,500/=. This can be furnished by depositing cash with this Authority or producing a bid security guarantee from a reputed Bank or any other agency approved by the Treasury, payable 'on demand' in favour of the Chairman, Urban Development Authority, Sethsiripaya, Battaramulla, valid till 13<sup>th</sup> November, 2017. No interest will be paid on this deposit. A specimen form of bid security guarantee is annexed herewith.


The bid must be firm and valid for ninety (90) days from the date of closing of bids and subject to no variations or fluctuations in price. The sealed envelope containing the bids should be clearly marked the "Renovation of 04 Nos. Common Toilet Blocks in Ground Floor of Sethsiripaya Stage -I." at the top left hand corner and addressed to The Chairman, Procurement Committee, Urban Development Authority, 7<sup>th</sup> Floor, Sethsiripaya Stage - I, Battaramulla.

The sealed Bid should be deposited in the Tender Box maintained for this purpose at the Procurement Unit, Urban Development Authority, 7<sup>th</sup> Floor, Sethsiripaya Stage - I, Battaramulla on or before 2.00 p.m. on 14<sup>th</sup> July, 2017.

Bids will be opened immediately after closing of Bids at 2.00 p.m. on 14<sup>th</sup> July, 2017 at the Procurement Unit and the Bidders or their authorised representatives will be allowed to be present at the time of opening of Bids.

All bidders submitting bids are advised to visit and inspect the site before submitting the bids. The selected Bidder should be able to commence the work immediately and complete within a period of Three (03) months from the notice of acceptance.
